

Fischer Radio Interview #1

*The following is live radio interview #1 of January 13, 1999, from Budapest, Hungary.
It is a transcript of the files F_01_1.mp3 and F_01_2.mp3, which were downloaded on 2002/09/12,
saved from url=(0036)http://home.att.ne.jp/moon/fischer/.
It starts where Fischer first speaks at 6 minutes and 57 seconds into the first file,
and ends where Fischer last speaks at 5 minutes and 14 seconds into the last file. Interviewers words are indented.
I used phononic spelling for unfamiliar names, places, and words. "Small Talk" is typed with a small font size.*

Hello Bobby.

Hello ... Mulnar.

I am ... Mulnar from Hungary radio Calypso, it's a very famous radio in Hungary.

Yes, I listened to the radio: its music and talk right?

Yes. Do you like our music?

Yes, I like it. Its nice pop music.

OK, OK.

I would like to ask you:

You won in 1992 against Boris Spassky.

After that you didn't return to the United States, why?

Yes, I am sure you know why.

The match was over on early November. Then on December 15 I was indicted by a grand jury in Washington DC, for violating an executive order by then president George Bush, which was "You shall not do any business with Yugoslavia." And then they said if I return I will be arrested anywhere within the United States, in any State of the United States; and if I am convicted they say I have to spend 10 years in prison, plus a big fine, a minimum of 250 thousand dollar fine. It could be much larger because they have many separate counts of these charges, so it could be millions of dollars and 10 years in prison: for playing chess! which is absurd!

(Interviewer changes subject:) Why did you choose Hungary for your place to live; why didn't you move to a Greek Island, or Italy, or Monty Carlo?

I come and go: I'm in Germany, Italy, Austria; I move around.
I'm not a resident here, I'm just a tourist.
But I enjoy the mineral baths here, and I like the people,
and I've been having a very nice time.
This is a fabulous city you have here.

(Interviewer changes subject:) Mr Fischer, you will now be heard not only here in the Budapest area through Radio Calypso, but this is the time for a three minute duration when you are heard throughout the Country.

Oh good.

(Interviewer changes subject:) With who do you have connections here in Hungary?

With who?: I am a fairly private person.
I have some friends. I move around, the baths, the restaurants.
That's a personal question.

If I could say something, since we're on nationally for three minutes; we might as well get to the heart of this matter, then we can come back to chit-chat. You know what's going on is I am being persecuted night and day by the Jews. I'm telling it like it is. They want to put me in jail. They're robbing me of everthing I have. They're continuously lying about me. I've had enough of this shit!

The latest thing they've done is:
I had some stuff in storage back in Pasadena, for twelve years. I spent a fortune on storage fees, a fortune on buying safes and expensive file cabinets, and movings, and so on, and putting it all together over like thirty years!
And these goddamn Jews in America have just gone and grabbed it all!
It's not mine anymore. This stuff is worth millions.

And I have letters from president Nixon, a book from president Nixon, a letter from president Marcos of the Philippines, photo albums with president Marcos; posters, books, files, contracts, you name it. And these goddamn Jews are stealing everything. They stole it from me! I've had enough.

(Interviewer changes subject:)

How do you remember the Manhattan Chess Club, when you were 13?

This is a bit of a non-sequitur. We were talking about something completely different. Are we still on nation wide or is that finished?

I think that's finished.

OK. So we have some time. Alright

The Manhattan Chess club ...

you know this is a long! time ago, when I was 13, I'm 55 ...

yes, I used to go to the chess club when I was a boy. What about it?

(Interviewer changes subject:)

When you were 15 you were twice American champion.

The youngest grandmaster in America.

Don't you miss this role now: that you were in the heart of the chess world and you were a champion?

I like to reminisce as much as anybody, but:

I want to get into some of the more current things, if you don't mind.

We can always come back at some other time

to some of these trivia questions, lighter stuff.

Right now:

The Jews want to put me in prison for 10 years.

They have forged an edition of "My Sixty Memorable Games".

I get no money for the genuine edition of "My Sixty Memorable Games", in English, French, every language.

There's a movie "Searching for Bobby Fischer",

that's made Paramount Pictures tens maybe hundreds of millions of dollars, exploiting my name ... I get nothing.

There's an illegal CDrom called "Bobby Fischer Teaches Chess", in violation of my contextual rights. I get nothing for that.

They're advertising a FIDE chess clock that uses my system,

they're using my name all over the clock and all over the advertisements.

I get nothing for that.

And now, on top of this:

After all these years of paying storage fees,

after all these years of building up the files,

after all these years of protecting it with very expensive file cabinets,

and double doored drill proof safes with combination locks:

They just say: "You owe us 400 dollars, we just sold all your stuff at auction."

I've got the receipt! This is a rip off. This is criminal stuff.

(Interviewer changes subject:)

What's your opinion about the chess world elite:

Kasparov, Karpov, Kramnik, Anand, and the three best Hungarian chess players:

Almasi, Leko, and Polgar. And I want to go on in a friendly and peaceful manner, if you let me, Mr Fischer.

Yeh ... no: I'm afraid I don't want to "let you", because I am really ticked off at a current event.
I'm not interested in going into all this stuff, this is not what's on my mind right now.

Then you have the opportunity, please go on.

First of all let me say a few words, the Jews have said millions of lies about me,
let me say a few words about the Jews:

The holicost never happend ... OK ... they made it up for money.

(Interviewer interrupts:)

Mr Fischer that will be! a scandal.

This is the truth.

(Interviewer, in an incoherent fashion:)

Yes, and I mean that's your opinion, your know,

that's your opinion, and it's very difficult.

I know that you told me that you would speak only in a live radio interview,

but if you let me if possible a question:

you are talking about people that you are one of, is that right?

This is not true.

If you want to go to the little boys room we can see who's the Jew, you know.

(Interviewer, in an incoherent fashion:)

OK, but you know, if I can just put in my very little opinion here that, you know:

because of the media laws we sort of have to be balanced here,

and we have to say that this is strictly your opinion, what you say.

(That's right).

You know, "fun is fun", people can pull jokes on me and stuff.

But when they start stealing everything I've worked for, all of my life.

When they take "My Sixty Memorable Games": Batsford has an edition
of "My Sixty Memorable Games" that is forged: they have changed my words,
they have changed my variations even, to make me look like a horse's ass!

It is one thing after another!

And whenever you trace who's behind it: it's always the Jews.

And now they have robbed my prized possessions in storage, unheard of!

*(Interviewer interrupts:)
Yeh you told us.*

Well it bares repeating, and over and over again
because I want everybody to know what the hell is going on.

The Jews are always screaming about their? persecution; they're the persecuters.
Hitler said in "Mein Kampf" that the Jews are not the victims;
but they are the victimizers.

*(Interviewer, in an incoherent fashion:)
OK Mr Fischer I think people have heard that.
Mr Fischer you are a very very sad and destroyed.
I mean destroyed in your brain and in your life.
Because you can't return to your country.
And I mean it!*

*If you don't want to say anymore about this question,
then I have to say "thank you very much".
I am happy to speak with you,
and not happy to hear that you are so sad and you are so destroyed.*

Do you want me to continue or not?

I would like you to address some chess issues.

No, I want the hard issues.

So you wouldn't like to talk about the chess?

I want to finish what I have to say.

Um, OK would you do it briefly?

Yes.

Now let me get back to this storage thing where they've just stolen
millions or even tens of millions of dollars worth of my possessions.
I want to say something about why the Jews chose this moment to
auction off all my belonging in storage.
Let me explain why they chose this particular moment:

(Interviewer interrupts with incoherence:)

Mr Fischer, in a live radio interview:

could you tell it in `ineditable´ instance what you say here in Hungary?

Let me finish what I'm saying here, OK?

(Interviewer interrupts:)

OK. Thank you very much.

(Interviewer turns off Fischer's microphone as Fischer starts to talk.)

Thank you.

(Interviewer talks to his coworkers for 5 1/2 minutes until the commercial break. Fischer is not heard anymore on this file.)

Fischer Radio Interview #2

The following is live radio interview #2 of January 14, 1999, from Baguio, Philippines. It is a transcript of the files F_02_1.mp3 and F_02_2.mp3, which were downloaded on 2003/06/27, saved from url=(0036)http://home.att.ne.jp/moon//fischer/. It starts where Fischer first speaks at 12 minutes and 14 seconds into the first file, and ends where Fischer last speaks at 1 minutes and 15 seconds into the last file. Interviewers words are indented. I used phononic spelling for unfamiliar names, places, and words. "Small Talk" is typed with a small font size.

How are you, Bobby?

Well, thank you, very well.

Eugene Torre is here with us right now, and he related to us your present problem: regarding your memorabilia in the States. Can you tell us something about it Bobby?

Yes, well this is just the latest in a long line of crimes against me, by world Jewery and the Jew-controlled United States of America:

Why are they doing this to you?

Because they don't like me.

Which properties of yours are now being sold by the States?

No: they've already been! sold, they're gone.
They said I owed them a few hundred dollars and (without contacting me) they just sold it all off. Stuff that it took me a lifetime to accumulate.

They broke open my safes, and broke open my file cabinets, and just sold off everything.
They sold off like a hundred boxes of my stuff.
They sold off my photo albums, my letters from President Marcos, my photo album with President Marcos ... everything.

This is just a conspiracy against me by the Jews, those filthy bastards.
You know: they're trying to take over the world.
They invented the Holicost story; there was no holicost of the Jews in WWII.
They've been pulling this shit from time immemorial about persecution.
They're a filthy, lying, bastard people:
that's all they've ever been, that's all they'll ever be.

Why do you have this thing about the Jews?

I have no "thing"; they have a "thing" about me.

Aren't you a Christian?

Yes I am.

Study your history. The Catholic church taught for a long time about how they are guilty of the murder of Christ.

Yes. So? Anyway Bob, these memorabilia that have been sold, that you owned ...

"That I owned"? I still own them, this is all stolen property you know.

I have spent on this stuff, just in storage fees alone, over ten thousand dollars.

I have spent it in:

Buying custom made safes,

custom made file cabinets with secret built in safes in the file cabinets,

a safe with special drill-proof doors, with a second door inside, combination locks, timers (in case somebody tries to force you to open it), ...

The works. To preserve my memorabilia:

my stuff from Marcos,

my letters from President Nixon, books dedicated to me by President Nixon,

photo albums, statues, ... the works.

They have stolen every fucking thing and sold it off, the dirty Jews.

They want to put me in prison for ten years.

They have sold all my memorabilia which I collected over the years.

They have stolen my book "My Sixty Memorable Games".

They've come out with an illegal movie called "Searching for Bobby Fischer", which is exploiting my name for money.

They've made ten, if not hundreds of millions of dollars on this movie,

I never get a penny of it.

The Jews have come out with an illegal CDrom called

"Bobby Fischer Teaches Chess", ... zero for me, I get nothing.

Even from the legitimate edition of "My Sixty Memorable Games", nothing!

These fucking Jews are thieves, they are liars, they are motherfuckers, ...

And it's time we took care of these bastards!

*I have photo copies of several checks you have issued a Mr Bob Ellsworth.
Who is this Bob Ellsworth?*

This guy was acting as my agent to pay my bills there in the States.
I have some stuff in storage in New York,
I had the stuff in storage in Pasadena (which has all been robbed),
I have two P.O. Boxes in Pasadena,
and I have some property in Florida, which I have to pay taxes on every year.
All these things come up to less than four thousand dollars.

So I was sending him five grand a year to take care of all this,
plus giving him like a thousand dollars for his trouble.
And he was paying it ...
but then he got the word from the dirty Jews:
“Fuck Fischer’s ass, sell his memorabilia”.
This was in collusion with this Bekin’s storage company in Pasadena.

What the hell? ... am I going to give away all of this stuff,
which I have taken years to accumulate and to preserve, over four hundred dollars?
I’ve got three million dollars in Switzerland, I’ve got dough here in Hungary.

They did it all behind my back.
Nobody contacted me, nobody contacted my lawyers, nothing.
The fucking Jews want to destroy everything I’ve worked for all my life.
There was no Holicost, the Jews are liars,
It’s time we took off the kid gloves with these parasites.

With all of these things, Mr Fischer, what do you intend to do now?

I intend to do what I am doing right now, which is to expose the Jews for:
the criminals they are,
the parasites they are,
the liars they are,
the thieves they are,
the murders they are.

You speak like an Arab.

They know! You ask the Palestinians. I was just listening to BBC, the horror stories that come out of there when you get into an Israeli Prison! The way they torture you, it's unheard of:

I was listening to Christian women from Palestine, who were anti-Israel; they got picked up by the Israeli police and were taken down to the jail. And then the Israeli police tried to get information: "Who do you know, among your friends, that's anti-Israel? Give us all you know about your Arab-Christian friends who are anti-Israel". When they refused they put the women in a cell, (these are mothers, these women, mostly.) and then they start playing in Arabic on the loud speaker 24 hours a day: (in a child's voice:) "Mommy come home, mommy we miss you, ...". They play it over and over again until the women just collapse.

This is the Jewish! mentality. These are a criminal! People. They torture their prisoners in the worst way. It's illegal but they don't even deny it hardly.

Jews were always bastards throughout history:
They are liars ...
They are the worst pieces of shit in the world ...
They mutilate their own children ...

Fuck the Jews.

*You don't plan any legal moves against them?, those that sold you memorabilia,
moves like a case in Court.*

Yeh, you know the Jews control the Courts too,
its just a charade they go through, a façade:

I've been involved in about five lawsuits in America throughout the years.

Never got a penny.

Never got a Stop Order.

Never got any property back.

Never got anything.

I spent a lot! of money.

I had all the documents and evidence,

I had all the justice on my side ...

... It's a joke! The "United States" is a farce:

controlled by dirty, hook-nosed, circumcized Jew bastards.

I used phononic spelling for unfamiliar names, places, and words. "Small Talk" is typed with a small font size.*

*Hello. We called you up again because, you know, since the interview we had several days ago
we've had several responses to that interview via the internet.
I would like you to respond to some of these comments they've made on the interview.*

Yeh, Yeh. Before we go any further, I would like to appologise,
because my language and the things I said about the Jews.

Hey, did you hear the one about what happened to the Jew with an erection,
when he accidentally ran into the wall?

He broke his nose.

*Alright, OK. So let's get the ball rolling with the first question.
But do you have anything to say in particular before we start?*

At this point the audio becomes too distorted by something
that sounds like heterdyning. I will try to fix it,
but for right now I might
move on to interview #6 which is clear.
